

## REBELS!

Below is important information on COVID-19 and entering Norway for the Nordic Rebellion.

### If you are fully vaccinated

(two doses + one week) when you travel, you will be able to enter.

- You need to show COVID-19 certificate.

### If you are NOT fully vaccinated

when you travel, it is now unlikely that you can enter Norway (until you *are* fully vaccinated).

- Starting Monday 16th of August, many Swedish regions will turn orange or red. If you live in an area that's green now, you satisfy other conditions, and can travel before your region turn red or orange, you may make it.
- Some rebels have heard that they can enter from orange or red areas and quarantine. However, this is only possible for Norwegians, or in specific cases which would apply to very few rebels (spouse in Norway, work or study, etc).

### Do not attempt to sneak into Norway

- Police check essentially all travellers and turn people away at the border.
- Regardless, please respect the wish of XR Nordic Rebellion and our hosts XR Norway to follow travel-restrictions.
- NR Media Press-team believe that rebels following COVID regulations is essential for us to get our important messages heard during the action week.
- The question of border is sensitive to many Norwegians because of government decisions made earlier in the pandemic. Entering in violation of COVID safety restrictions risks very damaging media attention and possibly big fines for XR Norway. XR Norway's important work could face a setback for years.

# Traveling to Norway – 2 options

## 1. COVID-19 certificate

- Fully vaccinated  
7 days since the second dose, 21 days if you have a single dose vaccine
- Recovered from corona  
during the last 6 months

You must document this at the border with an **EU, Swedish or Danish** COVID-19 certificate. Border control will scan the QR-code on the certificate.

### Bring your passport

For both options – The border control must be able to verify your identity.

**You cannot quarantine if you live in an orange or red region** There are some exceptions if you are a child traveling with your parents, have close family in Norway, work in Norway e.g. [See if any of the exceptions apply to you.](#)

## 2. Living in a green country/area

- You are resident in a green area in EU, EØS, Schengen and have stayed in a green area for the last 10 days. See [map of green areas](#)

If you travel through an orange/red area on your way to Norway you must travel: Without using public transport, without spending the night there, and without having close contact with others (except the people you live with)

- You must [register your travel](#) before you go
- You will be tested on the border
